Terms & Conditions

BLUE EYE INDIA PRIVATE LIMITED will, hereinafter be referred to as BEI.

1. BEI will allot space / stalls to Exhibitor (s) on a first come first served basis
2. BEI shall acknowledge this Application Form only on receipt of duly filled Space Booking Application Form along with 50% Advance Payment by DD / Cheque / NEFT. However, BEI has the discretion to nullify the application form in case of non availability of space. In such case, advance payment will be refunded within 10 working days from the date of acknowledgement.
3. The balance payment of space / stall charges shall be made in full by one month before of the Exhibition. In the event payment as aforesaid, BEI reserves the right to cancel the booking and the advance paid will stand forfeited.
4. All Cheque / DD's to be made in favour of BLUE EYE INDIA PVT. LTD. Payments in cheque shall not be treated as having been completed until such time as the cheque is realized in full ;
5. BEI will make appropriate security arrangements. However, BEI shall not be liable for any loss and / or damage to Exhibitor equipment, display materials, samples etc. due to any reason whatsoever.
6. BEI reserves the right to re-posses or re-allot space / stall which is prior to inauguration but not occupied at the time of confirmation and the Exhibitor(s) shall strictly adhere to it;
7. The schedule of the space / stall possession shall be given to the exhibitor at the time of confirmation and the Exhibitor(s) shall strictly adhere to it ;
8. Exhibitor(s) will care for the flooring, walls and all other structures during the space / stall decoration and also while bringing and removing materials. On these matters follow such instructions as BEI provides from time to time. This is essence of the contract.
9. Exhibitor(s) shall ensure that no hazardous or inflammable materials are kept in the space / stall and shall also ensure to adopt adequate safety measures in this regard ;
10. Exhibitor(s) shall make good to BEI all costs, damages and expenses resulting from fire, or any damages caused to the structure etc. due to Exhibitor's negligence;
11. Exhibitor shall ensure that all demonstrations, interviews, advertising, promotion and other sales and marketing activities are conducted within the space / stall. Aisles must always be kept clear for visitors ;
12. Audio / Visual displays may be conducted within he space / stall at low volumes ;
13. BEI does not accept any responsibility for any misquotations or other errors that may occur in the compilation of any publication related to the exhibition;
14. a) In the event of the cancellations of space / stall booking, advance payments made towards the same will be forfeited ;
b) Reduction in booked space / stall area will also be treated as cancellations of entire space / stall area booked, and advance payment made towards the same will be forfeited;
15. Exhibitors must ensure that the interior decoration of the space/stall is completed before the inauguration as per the time indicated in the schedule which will be given to the Exhibitor upon confirmation of Participation ;
16. Exhibitor(s) shall ensure that the space / stall is vacated as per the time indicated in the schedule which will be given to the Exhibitor upon confirmation of participation. BEI will not in any way be responsible and / or liable for the general security after the close of the Exhibition of the last day;
17. BEI has the full right to change the venue and date of exhibition without any prior notice.
18. Foreign participants should send their scan copy of VISA and passport one month prior to the exhibition starts.
19. If the local administration or local Government authorities do not allow us to allocate the stall/space for foreign participants on the respective exhibitions, in that case BEI will not allow any foreign delegates / participants to take part in the said exhibition.
20. BEI will not allow any foreign participation to exhibit any kind of unauthorised or unlawful product or services in the exhibition which is against land of law. If it happens, the penalty will be abide by the foreign participants itself
21. If the Exhibitor(s) commits any breach of this contract and fails to remedy it promptly on receiving written notice from BEI then BEI may, by a written notice, terminate this contracts. Upon termination under this clause or otherwise, Exhibitor will forthwith vacate possession of the same. Exercise of rights under this clause will prejudice any rights or remedies of BEI;
22. BEI will not be liable for any delays or failure in performance of any of its obligations under, or arising out of the contract, if the delay or the failure results from any of the following : Force majeure, acts of God, fire, flood, earthquake, storm, explosion, accidents, riots, strickers, lockouts, band/ closures, war, civil unrest, industrial disputes, embargoes of any state of emergency, or any other Govt. Act law, statute ordinance whatsoever which renders it impossible or impractical for BEI and Exhibitor(s) to perform and all previous negotiation, commitments, agreements between parties pertaining to this transaction stands cancelled ;
23. Organisers will not be responsible for the provision of stabilized power at the auditorium.
24. The foregoing terms and conditions shall prevail notwithstanding any variations contained in the terms and conditions or other documents, submitted by the Exhibitor(s) :
25. The parties agree that competent courts Kolkata only shall have exclusive jurisdiction of all disputes arising out of this contract.
26. Govt. formalities for the Exhibitor should be done by themselves.
27. Any promotion by the Exhibitor should be done on accordance with the law of land.
28. BEI has no responsibility during transition of Exhibitor in cross borders.
29. Two sides/Three sides/Island space cannot be closed by the exhibitor(s) from the opening side of the passage. Height should be maintained/restricted to 10ft only. In this regard, the designs should be approved by BEI prior to 15days of respective exhibitions, otherwise BEI has the sole right to penalize Rs. 1lakh. from the participant.
30. BEI will not allow any exhibitors to use or distribute any plastic carry bags in and around the exhibition area. Eco- friendly bags are highly recommended.
31. Exhibitor(s) are requested to place their extra requirement at the time of booking the stalls with the requisite amount. No further requirements will be entertained once the exhibitor(s) place their final order.
32. Exhibitors are required to take the necessary permissions from BEI to engage any vendors.
